**Open Forum/ Announcements:**

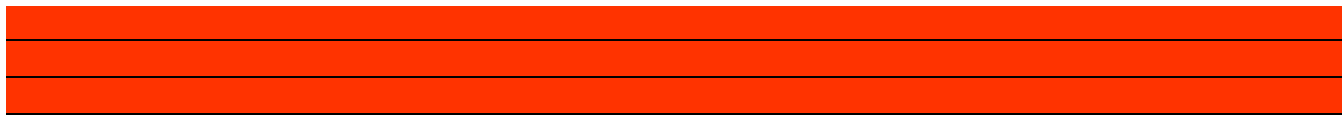

Justin L. with Recovery by the Books, is the first FDC Liaison chosen by a home group. Thank you for your service!

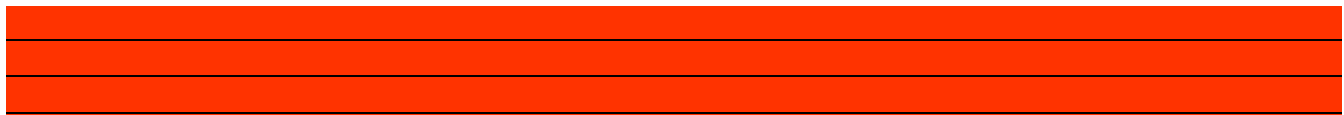
