# Money in NA

Money matters and, in NA, money matters a lot. NA World Services has published two Informational Pamphlets (IP's) about money:

- IP #24 Money Matters: Self Support
- IP #28 Funding NA Services

IP #24 is the main IP about money and it replaced the old IP "Hey, What's the Basket For?" IP #24 talks about why we give, and it talks about how much to give without stipulating a specific amount. It also talks about our service structure: Area, Region and World, and the importance of money in getting our message out. It is the basic and comprehensive discussion of money in NA in a pamphlet.

IP #28 Funding NA Services came out in about 2010 and speaks directly about sources and uses of money at the NA World Service level. For the first time in an NA Informational Pamphlet, there were instructions on how to donate to NA World Services directly.

At the group level, we know we need money to keep the doors open and to provide an atmosphere of recovery in our meetings. Imaging a meeting without coffee. Once we go to the Area level, it starts getting complicated. Most addicts who have attended and participated in Area Service meetings will agree that the most animated disagreements typically occur over money. This only continues and increases at the Region and World levels.

Members will sometimes talk about World Services in terms of what they spend money on and what they should or should not be doing. One current issue that can bring the mission of NA World Services into focus is how much funds to allocate to world-wide literature. At Have you encountered any consequences from your addiction which have persisted into recovery, such as barriers to employment? How have you approached these?

Yes, felony convictions unfortunately do not go away. Finding work was and continues to be a challenge. After many unsuccessful job interviews, I was offered an \$8 per hour sales position, which I reluctantly accepted. Over eight years later I still work for the same company. I am currently researching how to become a licensed professional in Florida, I face many challenges in this pursuit, but I am trying to make decisions out of faith and not fear.
